The domestic workshop aims at raising the awareness for the need for adaptation monitoring and evaluation as well as provide a platform for exchanging experience and taking stock of recent developments on, and potential for future deployment of indicators and monitoring for climate change adaptation in Montenegro.

The workshop will focus on latest developments and processes in adaptation Monitoring and Evaluation (M&E) and relevant indicators at national level in Europe. EU Member States representatives will showcase practical experience with indicators in M&E in their national adaptation strategies (NAS) and national adaptation plans (NAP) and share their lessons learnt and discuss their approaches to commonly faced challenges with Montenegrin colleagues. The inputs and knowledge showcased and discussed should aim at further developing the Montenegrin M&E system for its NAP. Interactive exchange with Montenegrin stakeholders will enrich the adaptation process in finalising and implementing the NAP, as well as its link to the UAE Framework for Global Climate Resilience agreed at the last COP28 in Dubai in 2023.
