## Aim of the Expert Mission:

---

The main objective of the expert mission is support efforts to increase domestic climate change resilience through adaptation planning and actions. The expert mission aims at raising the awareness for the need for adaptation and provide a platform for exchanging experience and taking stock of recent developments on, and potential for future deployment of climate change adaptation policy.

The domestic event in Montenegro will provide an informal discussion space to further progress towards developing a National Adaptation Plan (NAP) as well as promote the Climate-ADAPT Adaptation Support Tool (AST) use, e.g. for: strategic policy process, awareness raising, planning, development of guidelines, etc.

At the same time, the workshop intends to highlight and discuss how the AST can be used tailored to the real needs of users.

The last main objective of the expert mission is to inform about reporting requirements on adaptation. How this reporting is linked to adaptation policy development along the Adaption policy cycle, using the Adaptation Support Tool.

Finally, latest information on the developments of the NAP project proposal development will also be shared with all participants.

# NAP-1 Evaluation & Recommendations for NAP-2

## Achieved in NAP-1

- **Inter-institutional coordination mechanism** and National CC Commission established
- **National MRV System** enshrined in the law and **Roadmap for its further development** elaborated
- **Capacity Assessment for CCA** carried out and **Capacity Development Plan** elaborated (2014)
- **Connection of the national early warning system** with EuMetNet
- **Number of tools supporting capacity building and mainstreaming of CCA** into the sectoral policies developed:
  - ✓ Sectoral adaptation plans (SAPs) for the forestry and health sectors (never formally adopted, but used for planning)
  - ✓ A tool kit and recommendations for mainstreaming CCA measures into the energy and transport sectors
  - ✓ Capacity assessment and capacity building plans for the HydroMet Service
  - ✓ A tool kit for CCA mainstreaming
  - ✓ Climate Budget Tagging (CBT) guidelines

## Recommended for NAP-2

- **Operationalization** of the National Climate Change Commission and the coordination mechanism (ToR, mandates, formal secretariat)
- **Targeted institutional strengthening and capacity building** for all stakeholders involved in planning, budgeting, monitoring and evaluation processes relevant to climate change
- **Building of a functional database (one-stop-shop)** with regularly updated and reliable information relevant to climate change
- Establishment of a **fully-fledged early warning system** on climate-related disasters
- Better integration of CCA considerations into **strategic and budgetary planning, including on local (district) level**
- **Sector performance indicators** to monitor policy implementation and progress to CCA-related goals to be applied consistently
